New Hampshire Funders Forum Directory

The New Hampshire Funders Forum Directory provides profiles of private grantmaking institutions that invest in New Hampshire and actively participate in the New Hampshire Funders Forum. The Directory is updated annually by participating funders. The May 2024 public release of the Directory includes 29 funders.

The profile for each funder includes the name of the funding institution, background information, and funding information (including issues areas, geographic areas, types of support, and funding limitations). Information about how to apply for funding is provided along with financial details about the institution and contact information to reach an organization executive. The section on collaboration allows funders to provide examples of co-funding with other grantmaking institutions or their interest in co-funding. In addition, collaboration refers to other types of coordination among funders, such as partnering to promote an initiative or support a coalition effort involving multiple entities to advance a shared cause (i.e., NH Alliance for Healthy Aging, Children's Behavioral Health Collaborative).

The New Hampshire Funders Forum is making this information available in the Directory with permission from participating funders who have reviewed and approved their profiles. Readers are encouraged to visit an institution's website or contact the primary or secondary person listed in the profile for additional information.

The New Hampshire Funders Forum

The New Hampshire Funders Forum is a group of foundation leaders representing private and quasi-public philanthropic institutions whose assets are invested to benefit New Hampshire citizens. Participating funders include private foundations, corporate funders, family foundations, and grantmaking public charities that also manage donor advised funds.

In 2018, after several years of gathering informally to exchange information, participants adopted a charter. The charter expresses the group's commitment to exercising collective leadership that unleashes the strength, vibrancy and diversity of our communities; applying equitable and just approaches to collective work; and advancing strategic grantmaking opportunities to benefit all who live in New Hampshire.

The purposes of the New Hampshire Funders Forum are to:

- build relationships between and among foundations, corporate giving programs, and other institutional funders;
- learn from each other and guest experts about effective philanthropy, grantmaking practice, New Hampshire trends and issues, and related topics; and
- advance opportunities for collaborative funding and action.

The Forum is not an independent entity, nor does it have 501(c)(3) status. While the Forum offers opportunities for New Hampshire funders to engage in activities aimed at enhancing the impact of grantmaking in New Hampshire, it is not a formal philanthropic serving organization, and there is no membership fee for participation.

In 2021, groups of funders with shared interests formed three affinity groups that are affiliated to varying degrees with the wider New Hampshire Funders Forum, namely:

- 1) Diversity, Equity & Inclusion (DEI) Affinity Group which aims to successfully provide to the larger New Hampshire Funders Forum participant body annual opportunities for collaborative learning, funding and action that result in tangible, measurable (quantitative and qualitative) improvement to diversity, equity, inclusion, and justice in New Hampshire;
- 2) New Hampshire Early Childhood Funders Collaborative whose member institutions provide philanthropic support to New Hampshire's early childhood sector by regularly networking and learning together to inform how they act together; and
- 3) New Hampshire Philanthropy Report Advisory Group which includes funders, a representative of NH's nonprofit sector, and a former official of the New Hampshire Charitable Trusts unit within the Office of the Attorney General in the New Hampshire Department of Justice, who assemble to guide the development of reports on institutional grantmaking to New Hampshire nonprofits and to manage the thoughtful release of information to public audiences.
